
# *Preamble*

Constitutions are the bedrock of Democratic Societies; they set the terms for those we imbue with Authority. These terms should not be written or prepared by those who have Authority. It is almost self-evident to Society that Power corrupts and absolute Power corrupts absolutely. Therefore, to prevent corruption from denigrating the guide of being - Our State, we require robust and precise Constitutions. We acknowledge that better Constitutions come from those who know themselves well enough to reject the pursuit of Power and pursue the correct notion of Wisdom.

*All I know is not all that could be known—Mā te kimi ka kite, Mā te kite ka mōhio, Mā te mōhio ka mārama. Seek and discover. Discover and learn. Learn and eternally pursue Wisdom*

A Constitution aims to identify how the State can move away from guiding Society towards dictating to Society. A Constitution seeks to embody Ordered Liberty through difficult discussion and debate. A Constitution seeks to embody the knowledge of the many iterations of the Individual.

*Pērā i te Kārearea, ko te aranga ake i muri i te hingana.  
Like the Falcon, the rise comes after the fall.*



This Constitution creates a new way of facilitating a State whilst acknowledging its intention. A Constitution also acknowledges where the State can go wrong and implements countermeasures that reinforce the Rights and Freedoms of those protected by the State.

***Ko te hunga katoa e mau ana I te mana me te kii i te mohio me pehi e te hunga kore mana - Te Tangata***

***All those who hold Authority and claim Wisdom must be constrained by those who hold no Authority – The People.***

This Constitution recognises the Treaty and Te Tiriti for what they are – documents that contradict and divide. These documents were formulated to forge an agreement between two small groups to govern a Nation in an infant state. However, this Nation is no longer an infant State and thus, requires a document that fits a Nation that has grown.


***Ko te tipu me te rakau ka hiahia ki tetahi taiao rereke kia tupu ai.***

This Constitution acknowledges He Whakaputanga as the first jurisdiction, enabling the right of all to pursue Individual Sovereignty through the exercise of proper being and proper understanding of Law. A Sovereign Individual is a way of being that succeeds at doing no harm to others and seeking not to harm their surroundings. May this Constitution bind the State to guiding our people towards that goal through right example.

This Constitution recognises the Natural order of Society. When People seek a solution to problems created by those who fall, they create a State. When the State seeks to make Society better for People, it helps People create Opportunities through businesses and Corporations. When those entities turn on the People and flip the Natural order of things, the People need to look to where things went wrong.

Let this Constitution be the embodiment of paying Attention so that our children may be prepared for the next assault on our Rights and Liberties. Look at the children, full of wonder.***



# *The Constitution*

*We, the Living People of this Nation, referred to as Nu Tireni, Te Ika a Maui, Aotearoa, and New Zealand. Cement ourselves as Guardians (Kaitiaki) and Authority (Mana Whenua) of the Continent known as Zealandia. To pursue a more logical and considerate pathway forward for our Nation, we establish the tenets of Natural Justice and a Uniform Code in conjunction with Common Law. We acknowledge our pursuit of Symbiosis with our surroundings (Kaitiakitanga) and provide for the Defence of our Values. We aim to promote the General Welfare, earnestly pursue Individual Responsibility and secure our God-Given Right to Liberty. We establish this Constitution for our Nation. **Two Polarities, one Nation, in reverence of Ranginui and Papatuanuku, our perceived polarities of God, united by the similarities in our Beliefs.***

*This Constitution intends to separate Corporation from State. May this Constitution remind our descendants that Dogma can creep into the State in many forms. May this Document be a blueprint for future generations struggling under a State tiptoeing towards Totalitarianism. We hope that they stop drowning in the issues and turn to building the solution. They do not need to re-invent the wheel; they update it through Speech to address the issues of their time.*

*Let this Constitution be a reminder; the pursuit of Power requires Constitutional chains, Law and Democracy must pursue Truth over winning the argument. For the Human Race to thrive, they must pursue a deeper why to their existence.*



***Proclamation 1.*** *Those who serve a Constituency do not pursue Power but seek to empower all around them.*

***Proclamation 2.*** *Those who serve a Constituency acknowledge that Constituents are Living Beings; a Corporation or Artificial Consciousness is not a Living Being and, therefore, is not served by the State. They are constrained or opposed by the State.*

***Proclamation 3.*** *Those who serve a Constituency pursue Truth and therefore pursue Competency, those who pursue Popularity only serve themselves.*


***Proclamation 4.*** *Those who serve a Constituency know that all they know is not all they could know. A better Democracy seeks well-formulated criticism from its Constituency. A State does not pedestal poor opposition to justify its certainty.*

***Proclamation 5.*** *Those who serve a Constituency know that they facilitate great Power and understand that great Power needs a responsible and equal Common Deterrent.*

***Proclamation 6.*** *Those who serve a Constituency acknowledge that a Noble Lie is a lazy fallacy and only seeks to undermine confidence in the State.*

***Proclamation 7.*** *Those who serve a Constituency seek to embody the best of their Constituency; those who fail will make way for those who do not.*





**Proclamation 8.** *Those who serve a Constituency understand the sanctity of Self Determination (Turangawaewae) and the meaning of Sovereignty (Tino Rangatiratanga). Thus, we understand that Speech, Belief, Culture, Medical Choices, and Private Property are forms of Self Determination. Therefore, the two are not to be subverted under one's idea of Manaakitanga (Collective Support).*

**Proclamation 9.** *Those who serve a Constituency serve their Constituency first before serving those in need abroad. If we help ourselves, then more of us can properly help the world.*

**Proclamation 10.** *Those who serve a Constituency understand that none can Lead unless they know how to Serve.*

**Proclamation 11.** *Those who serve a Constituency serve it best by serving this Constitution; it shall not be subverted. It seeks to hold the line for Moral Objectivism.*

**Proclamation 12.** *All who operate in Central Government, Local Government, Law, Police, Military, and Society serve this Constitution in perpetuity. Those who seek to subvert the proper understanding of this Constitution commit Treason against the most high.*

**May this document separate Belief and Corporation from State by being the shield that guards the realm of the Living. This is the tablet that guides and restricts the State's Legislative, Judicial, and Executive branches. None who serve shall infringe on this Document.**

## ***Article. 1.***

### Section. 1.

The State Trinity shall be:

He Whakaputanga (The Declaration Of Independence)

The Constitutional Republic, held up by this Constitution.

Common Law that recognises Natural Law

The State shall consist of Central Government – Parliament and The House of Commons, Local Government shall consist of – Local Council, City Council, Suburb Representatives, and Regional Council.

All Legislative powers shall be proposed in Parliament house and ratified through two separate readings in Parliament and the Commons. The Legislation shall be debated publicly and then signed off by the Vice President and President. Binding Citizens-Initiated Referendums that deliver a definitive result (over 60%) can veto Legislation. ***Thus, binding Republican and Direct Democracy principles to avoid mob rule and the stagnation of the State.***

### Section. 2.


Our Democracy shall be Safeguarded by those who reject Power and pursue Wisdom; they shall be known as Electors. No Elector may hold governmental office after serving as an Elector and may not own or sit on any Corporate Board that does direct business with the State. Nor shall they own or sit on any board for a Monopoly that benefits from State Legislation.

To qualify as an Elector, the applicant must be Tangata Whenua as defined in this Constitution. In addition, they must be of the top percentile of an applicable personality and psyche examination, and they must be a scholar of Symbiosism (Kaitiakitanga).

The Electors may block any amendment to the Constitution through a public debate and a two-thirds vote. Accordingly, The Electors must be scholars of the Constitution's Holistic Intention.

Through Difficult Discussion, those who reject Power and pursue Wisdom will compete to be selected as Electors through National Debates on societal issues. Making up a total of sixty-five Electors from every Electorate, they will play the role of confirming the popular Vote or negating the popular Vote as a barrier to Foreign or Domestic Subversion. If an Elector decides on the latter and two-thirds of the Electors agree, the Elector region's election results will be audited, and the Elector's claims will be investigated.





An Elector cannot be a Local or Central Government member and must make their Financial Interests public. However, an Elector may be a Justice of the Peace and must reside in the Electorate they watch. An Elector found guilty of Electoral Fraud will be barred from voting and the Elector position for Life.

Section. 3.

The Parliament House and The House of Commons shall be composed of Members chosen every third year by Living People from their Electoral Regions.


Only Living People who pass a robust psyche and personality examination may represent their respective Electoral Regions. Additionally, they must hold the relevant knowledge needed for their specific representative post in governance. They must prove this through a universal examination conducted by the Representative's Party or a generic examination created by our Private Sector.

Legislative bills shall be proposed by elected individuals from existing Electoral Regions and Māori Rohe. All representatives will be selected via a democratic vote through Competent voters. The two electoral rolls (Māori and General) will remain. Rohe and Electoral Representatives must have one primary residence in their Electorate or Rohe.

This Constitution respects and acknowledges the First Jurisdiction of this Land: He Whakaputanga. May this Document serve to bring responsibility to the pursuit of Individual Sovereignty.

Each Electorate or Rohe may exercise their Constitutional Right to Self Governance, provided:

- The Electorate or Rohe in question succeeds in getting a 2/3rds affirmative result through a Regional Referendum.
- Every Legislative Act or Legislative Veto conducted through Regional Self Governance is Constitutional.
- Every Constituent commits to the diligent pursuit of the Sovereign Living Being. The region must demonstrate this in its lowering crime data.
- The region cedes to Natural and Common Law and respects the Judgement of The Supreme Court.
- That Unlawful Acts in other areas are enforceable in those areas. However, Offences, Orders and Mandates are not Law.
- They provide members of their Self Governing Electorate or Rohe Jurisdiction Identification Cards.



Those on the Māori roll may operate under different Legislation to those on the General roll in their Rohe and vice versa. Constituents operating under different Legislation in different areas may not commit Unlawful Acts concerning Common Law. For example, an Offence is not an Unlawful Act. However, if the governing Rohe recognises said Offence in their Legislation, they may accept that charge on their Constituent.

#### Section. 4.

Competent Voters shall be Citizens who pass a Competency Exam; they shall not be discriminated by age or ethnicity. In addition, they must show a valid form of Identification when casting a vote. The Competency Exam may not extend past: multiple-choice, our Country's Constitutional Values, Party policy details, and how the State functions.

The Electoral Commission will train Election day workers in the Election Year. All who work for the Electoral Commission shall be vetted; they must not be members of any party or have political or personal connections to Candidates.

The Electoral Commission shall run the Competency Exam; it must have multiple random versions, require a 65% pass grade, and be accessible in Electoral Offices with a recorded online version so the applicant can be seen taking the exam unassisted.

A Competency Exam may be specific to the available Representative policies in the voter's region.

There will be no mail-in voting; all voting must be done in person at a designated Voting Booth after producing a valid form of Identification.

A Voter only gets one chance to pass a competency exam each election year, as it will be a timed open book exam.

#### Section. 5.

Our Nation's Central Government shall comprise of 122 Representatives – sixty-five from the electorates, seven from each rohe, and fifty from party votes. Each MP shall have one Vote on proposed Legislation; Individual votes are not subject to party influence. Every Vote is an Individual's decision and should be a genuine attempt to reflect the directives and needs of said Representative's immediate Constituents.

Our Election shall occur every two to three years at a date set by public Vote through an Election Referendum – either at the 830-day mark or the 956-day mark. A snap election may also be proposed via a Binding Referendum initiated by an Affirmative Petition of 5% of the population.

Seat allocation will be set by importance – electorate Vote then party Vote percentage. The Vote Differential will rank electorate winners; the lower half of the eligible candidates on the Vote Differential shall cede in rank to the list candidates who got the highest proportion of the party votes (the top 25 Member party vote contingent.) To get a Member into Parliament, a Party requires 2% of the Party Vote.

#### Section. 6.

Party Vote shall not be one Vote per person; this Constitution regards the pursuit of Symbiosis/Kaitiakitanga as the guiding Philosophical Principle of this Constitution.

The comprehensive land surveys undertaken by previous Governments to implement SNAs (Significant Natural Areas) shall be used to bind Lawful Land Responsibility to Vote percentage designated to each Recognised Voter.

The square meterage of Lawful Land Responsibility will correlate towards the percentage of the Vote a Voter has. Suppose the Caretaker of said Land requires employees, tenants, or relatives to contribute to the responsibility for the Land. In that case, they are obligated to report a shared equal portion of that vote percentage with that Individual to the Electoral Commission upon written request.

All Lands managed by entities that require funds that require the People's Taxes will cede their applicable Land Responsibility to all those who pay Tax.

No Dead Entities shall Vote or Donate to a Party, only Living Citizens.

#### Section. 7.

This Constitution creates a Bicameral way of creating Laws. Accordingly, Parliament shall be split into two houses, The Commons (MPs who operate in their regions) and Parliament (MPs who operate in Wellington).



Electors must choose the President of the house by way of Elector vote. Although choosing the leader of the winning Party on aggregate is preferable, they are not bound to the Popular Vote. They will instead look to choose the Individual who best represents our countries values. The Vice-President will be chosen by the House of Commons to represent the best of the Common Interest.

Parliament will comprise candidates with the highest differential on win percentage and the most popular list candidates on vote percentage. The Commons will comprise the lower percentage aggregates of Electoral Candidates and the lower end of the collective party vote percentage. The twenty-four member Cabinet will be selected from Parliament by the Elector elected President. The House of Commons will select the Vice-President. The Vice-President will select the twenty-four member Cabinet Advisory Committee from The Commons. The Commons will spend the majority of their time in their Electorate working with their Constituents and Councils.

Section. 8.


No Individual shall be a Parliamentary or Commons Representative if they have not been a Citizen of our Nation for ten years. They must understand our Culture, Values, and Constitution's profundity. As aforementioned, they must pass the applicable psyche and personality examinations required to assess the Individual's Competency and Moral Integrity.

Election funding will be the responsibility of the parties and the candidates entirely; the State will not fund them. Donations may not exceed a maximum of \$1000.00 per Living Person per year.

All Parties must have Constitutions constructed by the members who do not have Authority in the Party. Therefore, all existing Party Constitutions are null and void upon enactment of this Constitution.

Party members must enlist the services of a Constitutional Lawyer and Constitutional Philosopher to aid in their Constitution's development.

Parties and Candidates may raise Money through sales initiatives but may not use Election donations to support that initiative. Media coverage for the elected hopefuls shall be evenly dispersed nationally and regionally, provided their party polls at over 2% of the Vote. Independent Candidates will get even regional coverage regardless of polling.



Our Nation's President shall preside over the Representatives in Parliament but shall not vote on Legislative Resolutions unless equally divided. The Vice President of our Nation shall preside over the Representatives in the House of Commons but shall have no vote on Legislative Resolutions unless they are equally divided. Two-thirds of both houses must agree to the proposed Legislation to pass both readings.

The President may hold and use twelve Presidential Orders during their Term of Office. The Presidential Orders must be Constitutional and used or allowed to expire during a six-year term.

One Living Individual may only hold the position of President for twelve consecutive years and no further.

Section. 9.

An Impeachment may be initiated if any member of both houses produces evidence that may implicate the President in Unconstitutional Actions.

Parliament shall house and debate all Impeachments; the Prosecuting Party and the Defendant Party must use Lawyers from their respective parties. If a Representative has no Party affiliate Lawyer, they may enlist one of their choosing. When sitting for Impeachment, they shall be on Oath or Affirmation. When our Nation's President is tried, the Chief Justice of the High Court shall preside. No person shall be convicted without the concurrence of two-thirds of the members present.

In cases of Impeachment, Judgement shall not extend further than removal from office and disqualification to hold and enjoy any office of honour, trust, or corporate under our Nation's entity register. The Party convicted shall nevertheless be liable and subject to a fair Indictment, Trial, Judgement, and Penance.

Moreover, if the plaintiff parties are found to have actively misled the Public or Parliament during the impeachment trial, they may be tried for those actions under Constitutional Law. They will also be subject to removal from office if they are found guilty of Deceitful Electioneering through Impeachment. Furthermore, any Lawyer who knowingly engages in dishonest Subversion of Public Opinion will be disbarred.



## Section. 10.

Electoral Candidates will work with Local and Regional councils to figure out what their Constituents and Infrastructure need. Local Government holds precedence over Central Government for managing their area and Infrastructure, and Local Referendums hold precedence over Councillor vote. If a Local Referendum petitions 50% of the area's population to veto a Council vote, the Council vote is over-ruled.

Councils must be actively considering their Constituents' reasonable requests and advice. Suppose it becomes apparent that they are not, or local Constituents are being unreasonable; the Council or Constituents may enlist an Independent Intermediary to resolve the dispute

City, Local, and Regional Councils own all Infrastructure wherein the ratepayers pay for the Infrastructure or loans. Councils shall be Incorporated Societies that operate under the express permission of their Constituents.


No Corporation or Central Government may own the Infrastructure maintained by ratepayer funds or loans that ratepayer funds pay. Nor shall any Corporation own any Council. It is the responsibility of Central Government to work with the Reserve Bank to fund all necessary Infrastructure and services with Interest-Free Credit.

## Section. 11.

If a Representative is caught in an Unresolved Contradiction, an investigation shall be conducted by the 65 Electors into the Narratives and Science surrounding that contradiction.

- The State shall pay for all legal work, the Chief Justice will preside over any cases and will undergo a personal bias examination before any lodged case.
- Electors will have full immunity from prosecution by the State during this investigation.
- All Social media restrictions will be lifted on all investigating at the behest of the Electors. Any Media Platform or Agency that defies this Order will be barred from our Country
- Any investigation interference from the State will illicit a snap election after the Elector's investigation. Any members found guilty of interference will be removed from office regardless of the outcome.
- If a serious crime has been committed, all involved shall be barred from public office and subject to the Crimes Act concerning that crime.

- Any complicit Corporations will be barred from operating on or over our Continent, and any contracts signed by complicit officials on the countries behalf shall become null and void.
  - The guilty Party is liable for all costs to the State through the pursuit of correcting the matter.

#### Section. 12.

Each Council shall be the judge of their elections, returns and qualifications of its members. A majority of each shall constitute a decision to do business except in the case of a referendum veto. A smaller number may adjourn from day to day and may be authorised to compel the attendance of absent members in such a manner and under such penalties as each Council may provide.

Each Council may determine the rules of its proceedings, punish its members for disorderly behaviour, and, with the concurrence of two thirds, expel a member for a clear breach of council rules.

#### Section 13.


Each Council shall keep a full publicly available recording of its proceedings and make it public record. Excepting such parts, as may in their judgment, cause harm to their Constituents through public exchange by being a matter of National Security. In addition, information of National Security Interest will be accessible to the Electors so they can determine the legitimacy of the need for secrecy. It is a Federal crime for an Elector to release said information without a two-thirds Elector vote in favour of releasing it.

The Office of the Ombudsman must release information to all Citizens requesting it. All information access that is denied for any reason, excluding not having access to said information, may be challenged through one of the 65 Electors.

Proprietary information withheld under corporate Law does not nullify an OIA request if the State advertises that product.

#### Section. 14.

The Council and Parliamentary Representatives shall receive compensation for their services. Ascertained by fair salary for hours worked, relative to all other similar forms of public service. Portfolio well-being metrics will be an incentive scheme set up and paid out by the Treasury.



An Independent Entity shall determine the well-being metrics and shall be proficient in data analytics and Holistic Interpretation

No representative is to have a financial conflict of interest generated by their actions in governance. If it is shown that they have benefitted or manipulated government actions for self-benefit and or the profits of an affiliate Corporation. In that case, the crime will be **Political Racketeering**, and our Supreme Court shall determine the punishment.

During an Election, no Representative shall be appointed to any Civil Office under the Authority of the State. Furthermore, no person holding any office for the State shall be a Council Member during their time in Parliament.

Section. 15.

This Constitution recognises the Reserve Bank as an Independent Entity owned by the State. This Constitution does not recognise the Reserve Bank as being owned by any other Entity. ***Accordingly, so shall it remain The People's Bank in perpetuity.***

All credit-creation proposals and revenue-raising shall originate in Parliament and the Commons. The Independent Reserve Bank Finance Committee may scrutinise and reject any credit applications for Government spending. The Government shall not borrow from the Reserve Bank for projects that do not Tangibly benefit the Public. In addition, any credit application sought for processes that bolster our Nation's pursuit of Symbiosis must be scrutinised by an accredited Regenerative Consultant before being lodged to the Reserve Bank.

The Reserve Bank shall remain as the principal bond lender for all lending facilitated in this Country. Its purpose shall be to pursue Price Equilibrium in the market; any Government or Entity that attempts to manipulate the Reserve Bank to do the opposite is breaching this Constitution.

The Reserve Bank may not charge Interest for any credit created for government spending on Infrastructure and Services. However, it may implement a fee scheme that develops the public loan lending branch for Tangible Value Enterprises designated as Regenerative.

A Citizen's Initiated Referendum may veto funding programs initiated by the Government that seek to use the Reserve Bank, private, commercial, or foreign lending institutions.



Section. 16.

MPs shall propose Bills in the form of Acts, Amendments, and Sections. They may not contradict other Acts, Amendments, and Sections. All such proposals must not contradict the proclamations and directives of this Constitution.

***This Constitution recognises the need for consistency when drafting Laws. Therefore, the Legislative Branch, the Judicial Branch, and the Office of The House of The Clerk must pursue consistency with high regard.***

All existing Acts, Sections, and Amendments that contradict other Acts, Sections, Amendments, and this Constitution; do not exist if they came after the Act, Sections, or Amendments it contradicts. ***Law is the embodiment of consistency.***


Bills shall be written in the Common Understanding; if Citizens struggle to understand Law and Legislation, then Direct Democracy is undermined. Terminology and Sections referenced in Legislation must reveal pop up definitions or explanations to help the public read Legislation easily. ***Syntax language shall be replaced with the Common Understanding so that Direct Democracy can work effectively in a Republic frame.*** Bills that do not pass a legally defined Vagueness Threshold shall not pass any reading.

Every Bill which shall have passed Parliament shall, before it becomes Law, be presented to the President of our Nation. If the President approves and no Citizen's Referendum has been initiated in opposition, the President shall sign it. But if not, shall return it. With the objections to Parliament in which it shall have originated, who shall enter the objections at large in the public record and reconsider it. If, after such reconsideration, two-thirds of Parliament agree to pass the Bill, it shall be sent to the Commons. It shall likewise be reconsidered, and if approved by two-thirds, it shall become Law.

Yeas and nays shall determine the votes of all MPs, and the names of persons voting for and against the Bill shall be entered into the public record.

Suppose the President shall not return any bill within ten days (Sundays excepted) after it shall have been presented to him. In that case, the same shall be a law, in a manner as if they had signed it. Unless Parliament and the Common's representatives by their adjournment prevent its return, in which case it shall not be a Law.





Every Order, Amendment, or Vote to which the concurrence of Parliament and The Commons may be necessary (except on a question of adjournment) shall be presented to the President of our Nation. But, before it shall take effect, it must be approved or disapproved by the President. If approved, it shall be repassed by two-thirds of Parliament and Commons, according to the rules and limitations for the case of a Bill.

Section. 17.

All taxes will be restricted to Financial Transaction Taxes and Capital Exit Taxes. Taxes will be redistributed to improve the General Welfare, Infrastructure, and our Nation's philosophical pursuit - the integrity of our adherence to Kaitiakitanga/Symbiosis


Parliament shall have the Power to implement Financial Transaction Taxes at every point of Credit Transfer. Furthermore, Parliament must allow open, honest, and uncensored scrutiny from Independent Organisations on any tax increases and poor use of Treasury.

Parliament may use these two taxes to pay debts and provide for the defence and General Welfare of our Nation's Living Beings. All taxes shall attempt to be uniform across the Country and must not allow technological advancement to impede the job preference of their Living Constituents.

Parliament is to borrow from its own Reserve Bank responsibly at zero Interest for the maintenance of our countries publicly owned infrastructure.

Our Currency shall be backed on the evolving digital analysis of the Tangible Value generated by our market. Furthermore, our Currency shall be bolstered by our brand. The brand rate on the international market should be judged on our products' Tangible Quality and Regenerative Status. This Constitution does not view precious metals stored in a way that renders them useless as a practical means of currency backing. Accordingly, our Nation will encourage our People to create more Tangible Value than Intangible Value to stabilise our Market prices.

Parliament, Treasury and the Commons will regulate commerce with Foreign Nations for Consenting Constituents. No other international entity shall regulate who we choose to contract with. Our Constitution will nullify any prior agreements between non-living entities as this is a Living Document representing Living People. This Constitution only recognises a specific interpretation of the 1835 He Whakaputanga document, wherein the pursuit of Sovereignty is granted to all and Ngati Wikitoria is recognised as a signatory.



The Reserve Bank shall be the issuer of coins and notes; Tangible Currency shall always be Legal Tender.

No Independent Entity may gamble on the success or failure of our Currency. All who do will be subject to our Federal Laws.

The Judiciary will provide for the Enforcement and Punishment of counterfeiting the Securities and current Currencies of our Nation.

Any Digital Currency created in our Nation must be backed on the value of our Brand, the value produced by NZ based automation, and the Tangible Value in our market. Furthermore, it must be accessible to foreign traders after it is first issued to our citizens.

Our Resource Production Data may not be used to generate value for any other entity except our Dollar. Regions that choose to self govern may contribute their Resource Production Data to their own formulated Currency or be a part of the collective Currency.

***Our digital and Tangible currency regulation*** shall be conducted by a Data Entity bound to the Constitution. This shall be done in partnership with the regulatory body of our Reserve Bank, and its goal shall be market Price Equilibrium.

The State shall enforce, regulate, or fine the trading of data obtained without the owner's contractual permission. In addition, all products that record and store data on their users must clearly and explicitly inform them of their proprietary data rights.

All Data is the Sovereign property of our Citizens; no entity shall have free use without attempting to garner the full informed Consent of the Individual. This shall be termed the guarantee of Data Sovereignty granted to all those who reclaim their birth certificate. That Individual has a proprietary right on all of their data if no such informed Consent has been secured.

***It is the responsibility of the State to inform its Citizens that their Data is coveted. Therefore it is the responsibility of the State to protect the Data Sovereignty of the people.***

Section. 18.

Only Living People may amend the Constitution through a two-thirds affirmative Binding Citizen's Initiated Referendum. However, suppose the Electors believe that a successful referendum subverts or undermines the consistency and proclamation intentions of the Constitution. In that case, they may block the amendment with a debate and a two-thirds vote.

Living People must understand, the Constitution intends to chain the ego of the State and keep it separate from Dogma. This Constitution views the State as an evolving guide for the Pursuit of Responsibility, not a Dictator that thinks it knows the Pursuit Of The Greater Good.

The State, in accordance with the Constitution, must maintain ownership on behalf of the people and maintain upkeep and Stewardship of Infrastructure that is designated as National Interest:

- At least one in each of Oil and Gas; Production and Refinery
- Our Public Health Infrastructure
- Our Roads, Rail, Airports, and Ports
- Our Military, Naval and Airforce Infrastructure
- Our Policing Infrastructure
- Our Educational Infrastructure
- Our Conservation Estates
- Our Continents Foreshore and Seabed
- Our Reserve Bank
- Our Public Service Infrastructure
- Civil Defence
- Public Transport
- A Constitutional Social Media Platform
- Data Infrastructure
- Shipping, Delivery, Import and Export

No entity can require our Nation to give up assets of National Interest through Contract.

The State must purchase entities that are designated as National Interest with the full Consent of the seller.



Section. 19.

The State shall constitute Tribunals inferior to the Supreme Court; The Supreme Court shall deal in Common Law, and all Laws shall cede to it, while Common Law cedes to Natural Law.

A Justice shall be a profession field of its own. Although some may have cause to think a Justice should have experience as a Lawyer, they will be chosen based on their ability to discern overall argument consistency and overall Law consistency.

Justices shall be appointed by well-advised Electors and shall be judged on;

- The rejection of personal bias and a mad adherence to Moral Relativism or Moral Objectivism
- Understanding of the Law they preside over, whether it be Civil Law, Corporate Law, Criminal Law, Common Law, or Natural Law.
- The pursuit of Legal Consistency and their ability to empathise with varying perspectives on an issue.

All Justices shall swear an oath to the Constitution and hold no oath to any Entity not aligned with this Constitution.

The State shall promote the Progress of Science and useful Arts by securing Authors and Inventors the exclusive Right to their respective Writings and Discoveries. No one may steal Intellectual Property through Patent Misuse.

The State shall define and punish piracies, offences and felonies committed on the seas of our Continent in partnership with our Australian and Pacific allies.

The State shall raise and support an Army, Navy, and Airforce suitable for protecting all Living Beings on our Continent. No Technology that kills shall ever be automated through Artificial Intelligence on the Continent of Zealandia. We consider the implementation of that to be a breach of our Constitution.

Through due Parliamentary process, the State may declare war in defence only and make rules concerning Land and water capture. Our Nation shall be committed to Katiakitanga/Symbiosis; we view all other wars over interpersonal or business relationships as less than childish.

The State shall make rules for the Government and regulation of the Land and Naval forces in line with the Constitution.

## Section. 20.

The Commons may rally the Militia in response to a State Totalitarian Act. The Commons may not necessarily be those in public service, but they must justify their reason through a fair and honest Common Law Court and a verified support base of at least 5% of the Country. If supported by the Electors, the Military and the Police must serve the Militia in arresting those engaged in a State Totalitarian Act.

A State Totalitarian Act seeks to legislate around the Constitution to undermine or eliminate Individual Sovereignty and Individual Liberty unjustifiably.

A State Totalitarian Act includes the misuse of Emergency Powers to contradict existing Legislation in service to an Ideological Goal or belief.

The State shall provide a regulatory process for arming the Militia, the licenced, law-abiding gun-owners. The job of granting licences to the Militia will be that of the local arms officer in conjunction with an independent psychologist of the applicants choice. The Military may employ their own arms officer and base psychologist for the arming of the Territorials and Military.

The State must conduct Gun Legislation in line with the intentions of the Constitution.

The State may allow independent licencing authorities to assist in the licencing and regulation of the Militia. However, they must operate per the goals of the Constitution.


- To increase individual responsibility around firearm ownership and use.
- To empower a responsible deterrent to State Tyranny.
- To strengthen the bond between Police, Military, and Militia.

## Section. 21.

All State Officers and the Militia must engage in regular therapy discussions with a therapist of their choosing.

All therapists must pledge an oath – not to manipulate their patients into becoming the embodiment of their ideology.

Every complaint lodged against a State Officer shall be referred to an Independent Anti-Corruption Department bound to the Constitution.



This Department shall be run by ex-State Officers who have served with Distinction. Distinction shall be determined through body camera footage analysis, conducted by footage analysts and supervised by the Anti-Corruption Department.

An Anti-Corruption Task-Force may investigate the State, provided two-thirds of the Electors concur that their reason has Just Cause.

According to this Constitution, the State shall allow the Military and the Militia to manage their hierarchy and advocacy entities.

The State shall exercise exclusive Legislation from within its respected chambers in accordance with the Constitution. The State shall exercise governance through Consent over the Continent of Zealandia and use Natural Law to protect its inhabitants from Foreign and Domestic threats. The Government of our Nation shall carry out all Powers vested by this Constitution.

Section. 22.

Our State Education System shall adhere to the intentions of the Constitution and shall not subvert it through the promotion of Ideological Dogma.

A Private Entity may facilitate schooling. Provided its education foundation is aligned with the correct interpretation of the Constitution.

Ideological Dogma that undermines the intentions of this Constitution shall not be taught in this Nation in perpetuity.

Section. 23.


The State is responsible for the regulation of all psychoactive stimulants and Medical Interventions. They shall be separated into groups;

- Synthetic Psychoactive Stimulants
- Organic Psychoactive Stimulants
- Organic Medical Interventions
- Synthetic Medical Interventions

The State shall pass Offences and Laws through Parliamentary Process concerning the manufacture, supply, and possession of the above Synthetic Substances.

The State shall pass Offences concerning the cultivation, supply, and possession of the above classifications of Organic Substances. But it may not pass a Law.





If uninformed harm is proven to cause health debilitation or death from consuming any of the above substances, Law created for Synthetic Substances may apply to Organic Substances.

#### Section. 24.

The State is obliged to engage in the constant improvement of transport infrastructure.

- The State shall pursue Sustainability and quality of road, rail, ship, air transportation, Infrastructure, and shipping.
- The State shall respect the intentions of the Constitution concerning works planned and implemented.
- The State shall seek to improve Transport Infrastructure so that long-term maintenance and resource reliance is reduced.
- The Reserve Bank will fund all Transport Infrastructure Works with Interest-Free Credit. The Data on the Infrastructure's impact on transportation efficiency and lack of impact on the environment shall bolster the value of our Brands.

***May the State pursue the correct intention of these Sections to elevate the standing of all who Kaitiaki to their Lands. May we be the Light Of Example to the rest of the world.***


#### Article. 2.

The State is obligated to help our Nation solve our Existential Issues first. This Constitution sets to frame these issues in a way that supports our Nation's Tikanga with the use of Science in conjunction with Wisdom and Moral Value. However, in the pursuit of solving these issues, the State may not engage in Totalitarian Actions. Article II dictates what the Constitutional Republic may or may not do concerning the creation of Laws, Offences and Orders. ***May the State seek to be an example to those who fall, so they may learn how to rise.***

#### Section. 1.

No State shall make any Law subverting the right to Free Speech. It is not the State's job to improve or police Speech; that responsibility is with the Education sector.

Purposefully inciting Mob Violence through Speech is a call to unjustified and unlawful action against the intentions of this Constitution.



The State may not claim to be the single source of Truth; as long as there are People, there will always be different interpretations of God. If People do not know what God is, then they do not know what Truth is.

The State must always financially buttress the ongoing facilitation of Debate and Difficult Discussion. In accordance with Proclamation 4, the State may not determine the affirmative and dissenting perspectives, a directly opposing view shall commonly represent the dissenting perspective.

No Entity may circumvent the Constitution's protections on Speech. It may contract people to abstain from Speech that harms the Pecuniary Interests of the contracting Entity, but it must provide evidence that the agreed-upon contract was breached.

May the Constitution serve to Protect the Free Exchange of Ideas, and may the Education System work to cultivate Narrative Harmony between Moral Relativism and Moral Objectivism.

#### Section. 2.

No State shall reduce the armament of the Militia (Licenced Law Abiding Gun Owners) to less than that of the State. The Nation's Militia must be maintained to equal to or above serving State officers. Independent Firearm Advocacy groups must hold a high standard of rapport with the State Police, pursuing a mutual goal of rejecting Tyranny and Chaos.


Through cooperation with the State Police, the Militia must pursue the highest levels of Individual Responsibility. May the poor actions of Individuals not bring the group into disrepute, and may the State seek educational and procedural reform to rectify issues with irresponsible or pathological acts.

#### Section. 3.

No State shall make any Law that impedes or takes away the Private Property Rights of Individuals and Maori Land. The State may advise and incentivise the pursuit of Symbiosis/Kaitiakitanga, but it may not use unworkable and unjustified Legislation that breaches the intentions of the Constitution.

The State must respect the right of The People to be secure in their persons, houses, personal information, and effects against unreasonable searches, surveys, and seizures. This shall not be violated, and no Warrants or Orders shall be issued unless there is evidence of probable cause to a crime. This must be supported by an Honorary Justice, particularly describing the place to be searched and the persons or things to be seized.





This Constitution does not recognise the existence of Crown land; there is no such legitimate entity known as the Crown. Therefore, all Land regarded as "Crown Land" will come under the cooperative Authority of The People under the protection of the State in service to this Constitution.

The same shall be true of all Crown entities; they shall become Incorporated Societies that are bound to the intentions of this Constitution. No entity managed by the State may be the property of any other entity; they are to be managed by those who prove to be the most Competent in their Department.

Management of Land that was regarded as Crown Land shall be negotiated between those who live in the immediate vicinity and subscribe to the Symbiotic principles outlined in Article 3. A State Department may manage this Land provided its management plan is better than those who live in the immediate vicinity. A State Department is bound to this Constitution.

The State should support the development of Kaitiaki-Based Property to buttress the Protective Management of Public Land with Interest-Free Reserve Bank Loans.

If a Living Person passes a State-approved application process that ascertains the Individual's knowledge of Symbiotic processes, Common Law, the Constitution, and passes the applicable psyche examination and Personality test. Then that Person may claim a Kaitiaki Title on Public Land within the Kaitiakitanga guidelines created by an independent and registered Regenerative Consultant.

Section. 4.


No State shall influence any Medical Practitioner to break their Hippocratic Oath. A State that engages in this act is committing A Totalitarian Act.

The State shall regard good health as a Holistic Pursuit; any State that knowingly engages in promoting a truncated approach to health breaches the terms of this Constitution.

Any State, Charity, Organisation, Incorporated Society, or Corporation that knowingly engages in the promotion of actions that deteriorate Public Health is committing Treason against this Constitution.

All entities that knowingly engage in the deterioration of Public Health are liable, regardless of any contracts written before the formation of this Constitution.





Any State, Corporation, Business Entity or Organisation requiring an Individual to undergo a Medical Intervention to maintain or engage in employment must be liable for any damages that may result from said Medical Intervention. The absence of causality without a science-backed explanation that implicates other causes does not remove liability from the employer.

No medical intervention may be granted provisional Consent for emergency purposes unless it has full informed Consent. In addition, no ingredients may be redacted for proprietary reasons.

No Insurance Companies may engage in Gambling Practices; all funds paid by those insured are the Payee's sovereign property. Furthermore, Insurance Companies may charge a supplemental fee that covers the administration of said Insurance funds. They must keep track of any arrears an Insured Living Person incurs and act as if all Money paid for future insurance needs are the property of the Payee.

Section. 5.

No State shall charge Emissions Taxes if it cannot prove beyond all reasonable doubt that this Continent is not Carbon Negative. The State must account for all means of sequestration and gas reactions when determining the need for an Emissions Tax. If it cannot justify the need by clearly showing its Tangible Benefit, it is Tax Fraud.

No State, Corporation, Charity, Organisation, or Incorporated Society shall engage in the Commodity Trading of Intangible Assets unless it can prove that the Intangible Asset has a Tangible Purpose. Carbon Credits can only be traded if the selling entity robustly represents the total Carbon emission and Sequestration Equation.

Carbon Credits and Land Use Rights are the property of the Land Title Holder; they may not be secured without the fully informed contractual permission of said Title Holder.

No State, Corporation, Charity, Organisation, or Incorporated Society shall engage in the Commodity Trading of Intangible Assets that are the Sovereign Property of a Living Being. Suppose any of these entities engage in trading said Assets without first garnering the Individual's fully informed and understood Consent. In that case, they are committing Fraud.

#### Section. 6.

No State, Corporation, Charity, Organisation, or Incorporated Society shall add Known Toxins to the water supply of another Living Being. If there is an Alternative angle that pursues the preservation of life diversity, the State will promote that instead.

No State, Corporation, Charity, Organisation, or Incorporated Society shall add Known Man-Made Toxins to Land that is under the care of another. This Constitution encourages all entities to move away from acts that create unintentional harm onto non-targeted organisms.

No State shall assist in Military operations that help Foreign Nations or Multinational Corporations steal Land from Symbiotic People. A State committed to Symbiosis aims to protect its People and then protect those who live with the Land abroad.

No State shall knowingly endanger the Welfare or Lives of wildlife that are not the target of sustenance and resource acquisition. Our Nation's Hunting Culture shall be embedded into our pursuit of Symbiosis/Kaitiakitanga.

#### Section. 7.

No State shall Legislate to diminish the value of Living Beings; the State shall not consider Life ending procedures as governed under the Health Act.


Life ending procedures are the Sovereign choice of that Living Person; no Entity or person may compel another to end another's Life. If the Living Person needs assistance to die, those who assist must convince an Honorary Justice that their decision to assist was Just.

Medical Professionals must first do no harm and heal before easing or hastening an immediately inevitable demise.

#### Section. 8.

No State, Corporation, Incorporated Society, Organisation, or Charity shall monopolise the News Media to subvert the People's values away from this Constitution.

This Constitution shall pursue consistency in Media by requiring Opinion to be kept separate from News Media. Thus, Journalists may not call themselves Journalists if they fuse Opinions and News.



No Opinion-based Media may frame itself as a News entity. This Constitution does not view personal or professional Opinion as a fair defence against issues with accuracy. Especially if the State or a State affiliate has a clear financial or ideological motive behind fusing Opinion with News.

No State, Corporation, Incorporated Society, Organisation, or Charity may compel a Journalist from doing their job; nor shall they arrest or dismiss them for doing their job. Except if they can prove they ignored the potential for great tangible harm and prove that tangible harm resulted from said action.

No State shall facilitate the persecution of health beliefs by Opinion Media; it is a breach of the intentions of this Constitution. Good public health is achieved through the same pathways as good Speech.

#### Section. 9.

All Social Media Platforms shall be regarded as extensions of our Society, as they are forums for Speech which is the property of Society. Therefore the management and governance of a Social Media Platform are confined to the restrictions of this Constitution.

All Social Media Platforms that operate like online societies must be bound to this Constitution to function in this Nation. All Social Media Platforms that breach this Constitution will be subject to our Laws and Judicial processes.

No Entity may take data from any of our Citizens for profit without purchasing said data through a contract subject to full informed Consent.

Every Living Person in this Country is granted Data Sovereignty by way of reclaiming their Birth Certificate.

#### Section. 10.

The State shall commit itself to defend the Mana Motuhake (Independent Sovereignty) of our Pacific relatives. If they so choose, we shall help them to reclaim it through Constitution.

No State shall legislate its way towards perpetually improving the collective psyche of the populace; the populace will reveal that through conversation. Therefore, the State is to maintain peace so that conversation can continue to explore.

#### Section. 11.

No State shall adjust the speed limit for revenue-generating. Instead, the State





focuses on promoting driver competency and responsibility, better road infrastructure, and better transportation.

#### Section. 12.

This Constitution adheres to the principles of Symbiosis/Kaitiakitanga. That is the philosophy that guides the path forward for the evolution of this Document. ***How we pursue this goal shall always be through difficult discussion, not undemocratic enforcement.***

#### ***Article. 3.***

The purpose of this Constitution is to designate the functions of the State (Article 1). To properly frame what issues the State may or may not Legislate to fix (Article 2). And what the Constitution considers to be of principal concern at its proposal (Article 3). Article Three will propose where our Attention should be directed.

#### Section. 1.

This Constitution recognises the need for Humans to pursue the why to our existence. Since humans seem committed to exploration, innovation, and the pursuit of a deeper meaning to their existence, this Constitution comes to a self-evident realisation. That in order to explore, innovate, and embody a life of meaning, we must overcome the tragedy of survival to traverse the Cosmos.

It seems apparent that in order to do this, Human beings must learn how to live in Harmony or Symbiosis with their surroundings. It seems far less likely that a species that aligns more with Parasitism would survive long enough to develop the tools necessary to traverse and explore the Cosmos.

This Constitution believes that a cycle of Tyranny that perpetuates Trauma and more Tyranny traps Human Beings in a survival loop. Thus, making us tilt more towards Parasitism and, therefore, failure.

Hence, this Constitution asserts that if the perpetuation of Tyranny and Trauma is not adequately addressed, then Human Beings will never achieve Symbiosis with their surroundings and will, therefore, never traverse the depths of the Cosmos. ***Therefore, the State must seek to be trauma-informed.***

This Constitution was born in response to the increased presence of Tyranny and Moral Relativism. This may have stemmed from a perception of radical service to preventing ecological catastrophe. This Constitution asserts that these lazy saviour approaches will only hasten our trajectory towards oblivion.

## Section. 2.

This Constitution recognises Biodiversity loss, Parasitism, Artificial Intelligence, Waste Management, Mental Health, and Cosmic Bodies as unaddressed existential planetary issues.

The State shall regulate the development of automation and AI on the basis of necessity, resource consumption, protecting workers rights, and risk-benefit analysis surrounding the potential for harm.

The State shall support the continued creation and upscaling of wildlife sanctuaries paired with Regenerative Economic Models.

The State shall adequately contribute to the innovation of defensive Infrastructure against Cosmic bodies.

This Constitution acknowledges the psychological loop of trauma that is a principal cause of the addiction that perpetuates the outwardly parasitic behaviour of human beings.

This Constitution sees waste as a poor label; nothing is waste, all bi-products can be re-utilised with the right innovation.

## Section. 3.

This Constitution seeks to erase the argument between Karl Marx and Capitalism. No Governance System can or should be termed as Capitalism; Capitalism is not a system; it is a market analysis process. Karl Marx did not create a working system; Karl Marx created a theory and an argument. People create systems and Constitutions for said systems to provide the best environment for thriving. An Ethos or Ism is a philosophical pursuit for Humanity, the pursuit of Capital or the pursuit of Unity at all costs is not a worthwhile pursuit for Humanity.

***Those who have the best Constitutions thrive; those who cling to Ideological Dogma and perpetuate vague imaginations of single-minded Utopia fall.***

# *Constitutional Terms*

**Constitution:** The composition, intention, operational rules, or structure of the State written by those who hold no Authority.

**Living People:** People who possess Life.

**Nation:** A group of people organized under a single Ethos. It may be expressed as a single independent country or collection of cooperative States.

**Aotearoa:** Land of the Long White Cloud, referring to the recurring mists that emerge from the forests and wetlands

**Nu Tireni:** New Territory, sometimes referred to as the original reference for this Country.

**Te Ika a Maui:** The Fish of Maui, sometimes referred to as the original reference for the North Island. The South Island being the Waka (canoe) of Maui.

**Guardian:** One that guards, watches over, or protects.

**Kaitiaki:** A person who acts with respect and care to all of their surroundings.

**Authority:** Power assigned to another through Consent; authorization.

**Mana Whenua:** Those granted Authority of Land through purchase, claim, and demonstration of recurring and responsible expressions of Kaitiakitanga.

**Continent:** That which contains or comprises. A landmass wherein its borders are defined by a continental shelf.

**Zealandia:** Also known as Te Riu-a-Māui or Tasmantis, it is an almost entirely submerged mass of continental crust that subsided after breaking away from Gondwanaland 83–79 million years ago. It has been described variously as a submerged continent, a continental fragment, a microcontinent, and a continent.

**Natural Justice:** Justice without bias; no person can judge in any case where they have an interest.

**Uniform Code:** The implementation of Law that renders all People equal under the Law.

**Common Law:** Law established by court decisions that align with Natural Justice rather than statutes enacted by legislatures.

**Symbiosis:** A relationship of mutual benefit or dependence on all that surrounds an organism.

**Kaitiakitanga:** Pursuing the act of Symbiosis with one's surroundings.

**Defence:** The action of protecting.

**Values:** Concepts or characteristics of importance to the perceiver; utility or merit.



**General Welfare:** The desire of the Government to promote the health, peace, morality, and safety of its Citizens.

**Individual Responsibility:** The assertion that human beings choose, instigate, or otherwise cause their actions and are, therefore, responsible for their actions.

**God-Given Right:** A special privilege or Authority bestowed to us by a higher Consciousness.

**Liberty:** The condition of being free from unjustified oppression or control by a Government or other Entity.

**Culture:** *The set of predominating attitudes*, customs, Beliefs, and behaviour that characterize a group or organization.

**Ranginui:** The Māori interpretation of the Divine Masculine of the sky, heavens, or Cosmos.

**Papatuanuku:** The Māori interpretation of the Divine Feminine of the earth or mother Nature.

**Masculine:** The ordered polarity of God.

**Feminine:** The chaotic polarity of God.

**God:** I exist, therefore I am.

**Corporation:** An entity such as a business, municipality, or organization that involves more than one person but has met the legal requirements to operate as a single entity. That way, it may enter into contracts and engage in transactions under its own identity

**State:** A condition or mode of being concerning the harmonious example to Society.

**Dogma:** A principle or statement of Opinion, or a group of such principles or statements, especially when considered authoritative or accepted without question.

**Totalitarianism:** A system of Government in which the people have little to no authority and a Government or Corporation wields absolute control, for example, the Chinese Communist Party and Pfizer.

**Law:** A rule of conduct or procedure established by custom, agreement, Nature or Authority.

**Democratic:** Of the Nature of or characterized by Democracy; pertaining to Democracy

**Democracy:** Government by the people, exercised either directly or through elected representatives.

**Truth:** Being in alignment with fact or reality, Truth is influenced by time and the accumulation of more knowledge.

**Human Race:** All of the living human inhabitants of the earth

**Constituency:** The body of voters or district residents represented by an elected representative.

**Power:** A source of influence or force that can be wielded over or in service to others.

**Artificial Consciousness:** Machine Consciousness that can self actualise its own direction, perspectives and interpretations of human directives.

**Competency:** To have Competence, The ability to do something well and efficiently.

**Popularity:** The quality or state of being popular, especially the state of being widely admired, accepted, or sought after.

**Common Deterrent:** The act of empowering what is common to deter the few's accumulation of Power.

**Noble Lie:** In politics, a noble lie is a myth or untruth, often, but not invariably, of a religious nature, knowingly propagated by an elite to maintain social harmony or advance an agenda. The noble lie is a concept originated by Plato as described in the Republic.

**Self Determination:** This is the personal decision to act or think in a way that most aligns with the Individual.

**Turangawaewae:** A place where one has the right to stand and be according to their internal dictates.

**Sovereignty:** The self-directed pursuit of being that demonstrates morality of the most high.

**Tino Rangatiratanga:** Above.

**Rangatira:** One who demonstrates Sovereignty in Speech and action.

**Speech:** The faculty or act of expressing or describing thoughts, feelings, or perceptions through the articulation of words

**Belief:** The mental act, condition, or habit of placing trust or confidence in other concepts or beings.

**Moral Objectivism:** The position that certain acts are objectively right or wrong, independent of human Opinion.

**Lead:** To guide on the way, especially by going in advance.

**Serve:** To assist in the pursuit of a goal under the direction of a higher purpose.

**Medical Choice:** The personal option to choose which medical interventions are implemented on your body to pursue good health.

**Private:** Not of the State, operating in the Private Sector.

**Private Property:** Property to which individuals or lawful entities have certain exclusive property rights but do not necessarily possess.

**Government:** A political Authority that garners permission to govern through Voter Consent.

**Central Government:** A political Authority that garners permission to govern nationally through Voter Consent.

**Local Government:** A political authority that garners permission to govern



Locally through Voter Consent.

**Law:** A rule of conduct or procedure established by Nature, custom, agreement, or Common Law.

**Police:** A body of Constitutional servants trained in law enforcement methods, crime prevention, detection and authorized to maintain the peace, safety, and Order of the community.

**Military:** Constitutional soldiers who protect the people of a country from subversion and attack by foes foreign, domestic and digital.

**Society:** A forum for people broadly distinguished from other groups by mutual values, participation in characteristic relationships, shared institutions, and a common philosophical pursuit.

**Treason:** The betrayal of allegiance toward one's own Country or Constitution, especially by committing hostile or subversive acts against it or aiding its enemies in committing such acts.

**Ideology:** A set of doctrines or Beliefs shared by the ideological group members that form the makeup of a political, economic, materialist or spiritual interpretation.

**Living:** Possessing Life.

**Legislative:** Of or relating to the development of Laws, Offences, Amendments, and Orders that are Constitutional.

**Judicial:** Of or relating to the enforcement of Laws, Offences, Amendments and Orders that are Constitutional.

**Executive:** Of or relating to the Proposal of Laws, Offences, Amendments and Orders that are Constitutional.

**Parliament:** A Representative body having part of the legislative and resourcing powers within the State.

**The House of Commons/Commons:** A Representative body having part of the legislative and resourcing powers within the State.

**Local Council:** A Representative body having part of the regulatory and resourcing powers within a Locality.

**City Council:** A Representative body having part of the regulatory and resourcing powers within a City.

**Suburb Representatives:** A Representative body having part of the regulatory and resourcing powers within a Suburb.

**Regional Council:** A Representative body having part of the regulatory and resourcing powers within a Region.

**Legislation:** The act or process of legislating; lawmaking.

**President:** The chief executive officer of a Constitutional Republic, with powers determined by a Constitution written by those who hold no Authority.

**Vice-President:** The vice chief executive officer of a Constitutional Republic,



with powers determined by a Constitution written by those who hold no Authority.

***Binding Citizens Initiated Referendum:*** A Legislative Proposal or Veto that blocks or erases proposed Legislation, Offences, Amendments, and Orders.

***Republican:*** Favoring a Republic as the best form of Government.

***Direct-Democracy:*** Sometimes called "pure democracy," is a form of Democracy in which all laws and policies imposed by Governments are scrutinised and determined by the people themselves, rather than the representatives.

***Safeguard:*** Something that protects against attack, loss, or injury

***Wisdom:*** The sum of learning through the ages; knowledge. All I know is not all I could know; a celebration of mystery.

***Elector:*** A Member of the Electoral College, a group of individuals who pursue Wisdom and reject the pursuit of Power.

***Corporate Board:*** A body elected to govern a Corporation on behalf of the Corporation's Shareholders.

***Monopoly:*** A Corporate or State entity that pursues dominance (over 33.3%) over the means of producing or selling a commodity or service.

***Tangata Whenua:*** People who see themselves as being of or belonging to the Whenua/Land. Those whose genealogical roots go deep into the Whenua/Land.

***Nature:*** The realm of Living Entities.

***Symbiosism:*** The philosophical pursuit of Symbiosis with one's surroundings.

***Holistic Intention:*** A consideration for the deeper meaning behind a collection of statements.

***National Debates:*** Formal discourse or argument on a topic or issue's content presented on a nationally viewed stage.

***Electorate:*** A body of qualified voters.

***Unlawful:*** Contrary to accepted morality or convention, illegal.

***Foreign:*** Located away from one's original Country and Ideology.

***Domestic Subversion:*** To locally undermine, overturn, or render ineffective (a rule or an established notion, such as morality, for example).

***Financial Interests:*** A financial interest is an ownership or investment stake in an entity, including the rights and obligations to acquire such an interest.

***Justice of the Peace:*** An official, especially one associated with a town or county, with Judicial Power over certain civil cases involving small amounts of damages and certain criminal cases involving minor offences, as well as exercising other limited powers, such as the Power to perform marriages, authorize Civilian arrests, and judge Common Law court cases of State Corruption.

***Electoral Fraud:*** Illegal interference with an election process, especially to

stage the desired election outcome.

**Electoral Regions:** A region that contains a specific body of qualified voters.

**Party:** A group of representatives selected for a common duty or mission.

**Private Sector:** The part of the economy controlled by individuals or private organizations and is not funded by the Government.

**Māori:** A group of valued people unique to our Continent.

**Rohe:** A region defined by hapū boundaries or Māori Electorate boundaries.

**Regional Referendum:** A referendum wherein the population of an Electorate or Rohe votes to separate itself from National Legislative Offences, Amendments, and Orders. Yet, they remain bound to this Constitution.

**Legislative Act:** An Act is a law passed by Parliament and The Commons. Before they pass an Act, it is called a Bill. There are five types of Acts: public, private, local, provincial, and imperial.

**Legislative Veto:** A resolution passed by both houses or a Citizen's Initiated Referendum of a legislature intended to nullify Legislature, Offences, Amendments, and Orders.

**Self Governance:** Is the ability of an Electoral region or Rohe to exercise all necessary regulatory functions without intervention from external Authority, so long as all regulatory functions are Constitutional.

**Sovereign Living Being:** A Being that is responsible and accountable for all their actions. They are Competent and do not give Consent to others to represent them in legal and political affairs. They know how to exercise their natural rights and live in harmony with Natural Law and Nature. Therefore, no Government can contract or compel to come under their Authority.

**Natural:** Present in or produced by Nature and Nature alone.

**Judgement:** The capacity to assess situations or circumstances holistically in an attempt to pursue truthful determinations.

**The High Court:** The highest court in the Country can hear cases from any jurisdiction and is bound by this Constitution, Natural Law, and Common Law.

**Offence:** The act of offending the State by breaching a crime prevention order (offence); an offence is not a crime.

**Order:** A dictate made by the State to prevent or limit the reasonable possibility of harm. An order is not Law.

**Mandate:** A directive made by the State to prevent or limit the reasonable possibility of harm. An order is not Law.

**Self Governing Electorate:** An electorate that is exercising Self Governance.

**Rohe/Electorate Jurisdiction Identification Cards:** An Jurisdictional identification card recognised by the governance body of an Electorate or Rohe.

**Citizens:** A person owing loyalty to and entitled by birth or naturalization to the protection of a Constitutional State or Nation.



**Competency Exam:** The assessment of someone's capabilities against the requirements needed to select an individual or group to a governance role.

**Electoral Commission:** A commission selected and delegated to supervise and bolster the integrity of an election.

**Electoral Offices:** Infrastructure that provides a space for members of the Electoral Commission to do their work.

**Voting Booth:** A booth in which a person can cast a private vote.

**Identification:** Proof or evidence of identity.

**Voter:** A Citizen who has a legal right to vote.

**Representative:** One that serves as a delegate or agent for another by Consent.

**Election:** The act or process of electing someone to fill an office or position of representation.

**Election Referendum:** A referendum used to determine a date for an election.

**Vote Differential:** A mathematical equation that determines how well an electoral candidate won their Electorate in relation to other electorate winners.

**Lawful Land Responsibility:** Responsibility granted to a title and owned by the titleholder to hold a specific title over Land. An Individual's contribution to the Land's Management garners them a portion of the Land Responsibility.

**Recognised Voter:** A lawful and Competent Voter who has passed a Competency Exam.

**Land:** The solid ground of the earth.

**Individual:** A Being that can declare their Sovereignty if they so wish, especially a human being.

**People's Taxes:** Money taken from taxpayers for State re-distribution.

**Tax:** A contribution for the support of public services, Infrastructure, and parts of the State deemed necessary by the taxpaying populace.

**Dead Entities:** An entity that does not have a Living manifestation; A Corporation.

**Section:** One of several components that make up a piece.

**Living Citizens:** See Living People and Citizen.

**Bicameral:** Composed of or based on two central legislative chambers or branches. An acknowledgement to the duality of Society.

**Wellington (Te Whanga-nui-a-Tara):** One of the central cities of our Nation, not necessarily the Capital

**Philosophical Principle:** A well thought out principle that searches out Truth, Law, assumption, or betterment.

**Common Interest:** Something that is of value to the common earnest being.

**List candidates:** Candidates that can be elected through party vote percentage.

**Electoral Candidates:** Candidates that can be elected through Electorate vote.

**Cabinet:** A body of living persons appointed by the President to head



Parliament's Executive departments and act as official advisers.

**Cabinet Advisory Committee:** A body of Living persons appointed by the Vice-President to head the Common's Executive departments and act as official advisers.

**Council:** A body of people elected or appointed to serve as administrators, legislators, regulators or advisers of a locality.

**Moral Integrity:** Honest and firm in the pursuit of moral being.

**Money:** A recognised medium that can represent Tangible Value and be exchanged for things of value.

**Media:** Means and institutions for publishing, platforming, and broadcasting information.

**Independent candidates:** Candidates that don't banner under a cooperative party.

**Legislative Resolutions:** The official expression of the Opinion or will of a legislative body.

**Donations:** The act of giving to a fund or cause that does not seek to gain status through profit.

**Presidential Orders:** A set of Constitutional Orders granted to a President for an elected term.

**Term of Office:** A length of time in office granted to an elected official.

**Impeachment:** The act of impeaching a public official, either elected or appointed, before a tribunal charged with determining the facts of the matter

**Unconstitutional Actions:** A Government action that violates the Country's Constitutional Authority and Rights defined and granted.

**Prosecuting Party:** Accompanied by just cause, one-half of the Representatives of both houses who allege that the President should be Impeached.

**Defendant Party:** The President or accused and those who defend The President or the accused.

**Lawyer:** One who is versed in the applicable Law, or is a practitioner of the applicable Law; one whose profession is to prosecute or defend suits in courts, or advise clients as to their legal rights, and aid them in securing those rights.

**Oath:** A solemn, formal declaration or promise to fulfil a pledge, often calling on God, a god, or a sacred essence as a witness.

**Chief Justice:** The Justice who presides over The Hight Court.

**Indictment:** A set of written criminal charges issued against a party, where a grand jury, under the guidance of a Chief Justice, has found that sufficient evidence exists to justify trying the Party for that crime.

**Trial:** A proceeding in which opposing parties in a dispute present evidence and make arguments on the application of the Law before a judge or jury.

**Penance:** An act of self-mortification or devotion performed voluntarily or

enforced to pay for the creation of harm or potential harm.

**Public:** Of, concerning, or affecting the community or the people.

**Deceitful Electioneering:** Using Media and State processes to subvert the Truth of reality to gain politically for yourself or an aligned Ideology.

**Subversion:** The act of overturning or overthrowing, especially as it concerns the subversion of the earnest pursuit of Truth.

**Public Opinion:** The perceived Opinion of the Public, the popular view.

**Local Referendum:** A referendum wherein the population of Region, City, or District Vote to veto a Council Resolution.

**Independent Intermediary:** An expert adept at giving unbiased advice through sound competence in argument analysis.

**Infrastructure:** An underlying base or foundation especially for Private, Region, Public, City, or District.

**Reserve Bank:** The main issuer of bonds and State credit, owned by the State, dedicated to fair market equilibrium and pursuing Regenerative Market Symbiosis.

**Interest-Free Credit:** Credit created to pursue necessary deflation in the market or necessary State spending for Public benefit.

**Unresolved Contradiction:** An assertion of the direct opposite to what has been previously said or affirmed. Especially if it isn't adequately corrected for when the opportunity arises.

**Personal Bias Examination:** An evaluation of an Individual's set of Beliefs or personal characteristics that may hinder their ability to view a situation critically and holistically.

**Social Media:** Interactive forms of media that allow users to interact with and publish to each other, generally through the Internet.

**Platform:** A replication of parts of Society, usually referred to as a digital Platform.

**Crimes Act:** An Act of the Parliament of New Zealand that forms a leading part of the criminal Law in New Zealand. It repeals the Crimes Act 1908

**National Security:** The safety of a country as managed through economic and political Power, intelligence agencies and diplomacy.

**National Security Interest:** An Infrastructure that serves as an Interest to the Security of our Nation.

**Office of the Ombudsman:** An investigative office that seeks out information on behalf of the Public through online requests.

**Holistic Interpretation:** Considering a situation, view, or act with a mind for the existence of multiple different interpretations.

**The People's Bank:** A Bank owned by the State on behalf of the people, its job



is to finance the holistic improvement of the Country through our values.

**Political Racketeering:** The act of using business or ideology to hijack the State's true purpose to serve another's interest.

**Civil Office:** An Office that conducts the State's Endeavours using funds from the State; a State Entity.

**Finance Committee:** A committee appointed to consider the financial issues of Representative funding proposals to the Reserve Bank and other Lending Institutions.

**Regenerative Consultant:** A person who continues to improve their knowledge surrounding the industry, conservation, and business models that seek to create circular resource systems that are symbiotic to their surroundings. They also develop, evaluate and implement said models as practical experience is needed to demonstrate the workability of the theory.

**Tangible Value Enterprises:** Business Enterprises that produce value with a coveted physical representation in the market; real value.

**Bills:** proposed Legislation under consideration by the Legislative and Executive Branch of the State.

**Act (Legislation):** See; Legislative Act

**Act(s):** The plural form of the process of doing or performing something.

**Amendments:** The act of changing Legislation for the better; improvement.

**Office of The Clerk:** An entity bound to sections of the Clerk of the House of Representatives Act 1988 that align with this Constitution. Their purpose is to assist the President, Vice-President and Representatives with legal, professional, administrative, and procedural advice.

**Terminology:** The vocabulary of technical terms used in a particular field, subject, Science, Law or Art; nomenclature.

**Syntax language:** A language pattern that seeks to combine rules and sentence structure to improve grammatical efficiency. However, its complex Nature makes it difficult for the Common Person to understand Legislation.

**Vagueness Threshold:** A process of Legislation analysis that rates the level or lack of precision imbued into the statement or Legislation.

**Financial Transaction Taxes:** Taxes automatically deducted at a point of Credit Transfer and redistributed in line with Government funding or debt repayment processes.

**Capital Exit Taxes:** Taxes that are automatically deducted when value produced on our Continent is moved out of our market for the benefit of another entity outside our market.

**Credit Transfer:** A method of payment in which an amount of Money (credit) is transferred directly from one account or hand to another, in the same or different bank.



***Independent Organisations:*** An Organisation that is run separately from the State; Privately run.

***Tangible Value:*** Something of physical value to people, animals, and the Land in an economy, embodied physically in the material world.

***Tangible Quality:*** The measurable physical quality of a product or resource in the market; for example, the nutrient content of food.

***Regenerative Status:*** The analysis of the Regenerative process that produces a resource or product in a Market.

***Intangible Value:*** Value that does not have a physical representation in the material world; for example, data.

***Living Document:*** A type of Document with a document management system created with a defined mechanism and process to edit, manage, control, review, revise, update, share and communicate each updated version of the Document accurately and efficiently. A Living Document pursues Truth just like the Living.

***He Whakaputanga:*** Our Declaration of Independence, the first jurisdiction for the Continent of Zealandia. A document that enables the creation of effective Constitutional chains for the State.

***Ngati Wikitoria:*** The tribal name for the signatory who declared Independence for those identified as Pākehā (whose roots stretch to other lands).

***Tangible Currency:*** Currency that is backed by something physical and quantifiable.

***Legal Tender:*** A physical representation of Currency that is granted a Legal Tender status; must be accepted as payment in perpetuity.

***Judiciary:*** The Judicial or enforcement branch of the State.

***Enforcement:*** The exercise of lawful force; compulsory or constraining action; compulsion; through the use of diplomatic rhetoric.

***Punishment:*** The imposition of penance or deprivation for wrongdoing.

***Securities:*** Financial contracts, such as shares or bonds, granting the owner a stake in an asset. They have two key features: they give certain rights to the owner, and they can be traded in the financial markets.

***Digital Currency:*** Money in an intangible digital form, used as a medium of exchange.

***Brand:*** A trademark or distinctive name identifying a product, service, or organization.

***Dollar:*** A type of Currency that is recognised by the label – Dollar.

***Resource Production Data:*** The Data on the resources produced on our Continent.

***Pursuit of Responsibility:*** A moral pursuit wherein the Individual seeks to accept the burden of responsibility placed on them by God through proper

being.

**Dictator:** Someone who behaves in a way that projects the Belief that all they know is all that needs to be known.

**Pursuit Of The Greater Good:** The theory that morality in individual acts are irrelevant if the collective outcome is perceived as good.

**Currency:** Money in any form when in actual use as a medium of exchange, especially circulating paper money.

**Foreign:** Of a place or Country other than the one being considered.

**Domestic:** Of or relating to a country's internal affairs.

**Ideological Dogma:** A set of Beliefs or ideas that are expressed as incontrovertibly true.

**Psychoactive Stimulant:** An agent, especially a chemical agent, that arouses or affects the mind or mental processes.

**Synthetic Psychoactive Stimulant:** An artificial or manufactured agent, especially a chemical agent, that arouses or affects the mind or mental processes.

**Organic Psychoactive Stimulants:** A naturally occurring agent that is created through a natural process. Especially a chemical agent that arouses or affects the mind or mental processes.

**Organic Medical Interventions:** The use of natural products as an approach to addressing a health affliction or in preparation for a potential health affliction.

**Synthetic Medical Interventions:** The use of artificial or manufactured products as an approach to addressing a health affliction or in preparation for a potential health affliction.

**Synthetic Substances:** A substance that is artificial or manufactured

**Organic Substances:** A substance that is natural or derived from Nature

**Transport Infrastructure:**

**Light Of Example:** An entity, person, group, or Nation that takes it upon themselves to bear Humanity's burden with selflessness, courage, Wisdom, empathy and integrity. In the hope that the world sees it as an example of being and acts accordingly.

**People of our Nation:** Those who view themselves as "of our Nation", the offspring of our symbiotic philosophical identity.

**Existential Issues:** Problems of principle concern to Humanity, especially related to the promotion of Life.

**Free Speech:** Spoken or written word that is not confined or micromanaged by the State, unless intentional calls to violence generate a real threat of harm onto others.

**Education:** The knowledge or skill obtained or developed through a learning process.



**Mob Violence:** Behavior or treatment in which physical force is exerted to cause damage or injury through a large and often disorderly crowd.

**Truth:** Being in alignment with fact or reality.

**Debate:** To engage in a formal discussion or argument in pursuit of Truth.

**Difficult Discussion:** A worthwhile form of conversation surrounding triggering issues that may stress the individuals involved.

**Protect:** To keep from being damaged, attacked, stolen, or injured; guard.

**Free Exchange of Ideas:** An environment in which people are encouraged to share their ideas with courage in the face of rejection.

**Narrative Harmony:** A place where perspectives contend with one another to pursue a new third perspective, rather than imposing dominance from one perspective onto the other.

**Independent Firearm Advocacy:** An entity separate from the State that advocates for the rights and encouragement of responsibility for their Licenced Constituents.

**Constituents:** People who assign Authority or representation onto another through a Consent-based Vote process

**Tyranny:** Unjust or oppressive Power exerted by one Entity onto another or a collection of others.

**Chaos:** A condition or place of great disorder or confusion; the unknown.  
In Light: The polarity that brings in Renewal.

**Private Property Rights:** The owner's peaceful possession, stewardship, and enjoyment of their legally purchased, deeded private property.

**Māori Land:** Land under the Authority of Māori, the management of which is determined by those elected to represent the shareholders in pursuit of the hapū's collective values.

**Warrants:** A judicial writ authorizing the search or seizure of property, arrest of a person, or the execution of a legal judgment.

**Honorary Justice:** One qualified in fair, unbiased and just Judgement in matters of Law.

**Anti-Corruption Department:** A Department of ex-State officers who served with Distinction monitor and police corruption in the State force.

**Distinction:**

**Anti-Corruption Task-Force:** A specialist arm of the Anti-Corruption Department; specialises in the precise investigation of officers of concern.

**Crown Entity:** A Fictional Corporate entity masquerading as the State. Made Fictional by intentional or unintentional deception and contradiction in Te Tiriti and Treaty documents. Made further irrelevant through the cooperation of He Whakaputanga and this Constitution.

**Incorporated Society:** A entity dedicated to promoting its values, the efficiency

and excellence of its operational procedures, or the resolution of a cause. Rather than the pursuit of profit margins and shareholder returns

**Competent:** Properly or sufficiently qualified; capable. As determined by an appropriate evaluation.

**Symbiotic principles:** A set of principles that seek to increase the biodiversity of one's surroundings; An array of values that Māori and Pākehā both share.

**Kaitiaki-Based Property:** A homestead dedicated to living with the Land by aligning economic processes with Regenerative land management models.

**Protective Management of Public Land:** The act of surrounding our Public Conservation Land with a halo of responsible home-based Kaitiaki.

**Interest-Free Reserve Bank Loans:** Loans that seek to eliminate the inflation contribution of Interest and reduce the cost of products through investment into production.

**Medical Practitioner:** Someone who practices medicine, whether by surgery, diagnosis, natural remedies, pharmaceutical remedies or other ways of healing poor health or promoting good health.

**Hippocratic Oath:** An oath of ethics historically taken by physicians is one of the most widely known Greek medical texts. It includes the principles of medical confidentiality and non-maleficence. As the seminal articulation of certain principles that guide and inform medical practice, the ancient text has more than historic and symbolic value. Swearing a modified form of the Oath remains a rite of passage for medical graduates in many countries. Moreover, it is a requirement enshrined in legal statutes of various jurisdictions, such that violations of the Oath may carry criminal or other liability.

**Holistic Pursuit:** Pursuing a philosophy with a mind for the entirety or holistic Nature of its content

**Public Health:** Consideration for the well-being of the people, for the people, and by the people. No individual may dictate the Public's Health needs; that is the responsibility of the Public or the Individual.

**Gambling Practices:** The wagering on something of value engaged in an uncertain outcome. The wagerer hopes to acquire more value if the outcome of the wager favours the wagerer.

**Payer:** One that pays for a service or product.

**Insurance Company:** An entity that provides Individuals with a monetary security net with their continual payments in case of an accident or tragedy.

**Pecuniary Interest:** An interest in a matter that could monetarily affect the said person.

**Entity:** Something that exists either tangibly or intangibly.

**Moral Relativism:** At its extreme, it is the idea that there is no universal or absolute set of moral principles. It's a version of morality that advocates "to



each her own," and those who follow it say, "Who am I to judge?" As a well-considered tool, it is the use of reason to test the justification of proclaimed moral principles.

**Moral Objectivism:** At its extreme, it is the position that certain acts are certainly objectively right or wrong, independent of Human Opinion. As a well-considered tool, it is a wise caution that mitigates extreme Moral Relativism.

**Militia:** Licenced Law Abiding Citizens who are not part of a regular army and are subject to call for service in an emergency. They swear allegiance to the Constitution to obtain a firearms licence.

**Symbiosis/Kaitiakitanga:** The conscious pursuit of acting to enhance one's surroundings in a way that increases the surrounding biodiversity.

**Crown:** A Corporate Entity that refers to itself as the Crown.

**State Department:** An Entity managed by the State to carry out the directives of this Constitution.

**A Totalitarian Act:** An act that seeks to undermine this Constitution for the hypothetical pursuit of an ideological goal or to address a crisis.

**Charity:** An institution, organization, or fund established to help the needy without the need for personal gain.

**Organisation:** A collection of persons (or committees or departments etc.) who make up a body to administer something.

**Emissions Taxes:** A form of negative reinforcement meant to discourage the use of fossil fuels, the justification for this Tax relies on its ability to solve an actual problem.

**Personality:** The totality of qualities and traits, as of character or behaviour peculiar to a specific person.

**Title:** A paper granting legal ownership or stewardship of Land.

**Commodity Trading:** Broadly understood as the process of sourcing (procuring), buying, transporting, storing, transforming and selling tangible or intangible commodities, including managing associated risks.


**Carbon Credit:** A certified carbon dioxide emission displacement credit, supposed to be equal to one tonne of CO<sub>2</sub> removed from the air.

**Sequestration Equation:** An equation that shows whether a country emits more carbon than they sequester. This is accomplished by analysing the carbon sequestration rate of all flora and vehicles and Infrastructure's carbon footprints.

**Property:** Something tangible or intangible to which its owner has legally obtained title.

**Fraud:** A deception practised to coerce another to give up possession of property or surrender a right.

**Alternative:** One of several possible choices or courses of action.



**Known Man-Made Toxin:** A synthetic Substance that is considered significantly toxic.

**Symbiotic:** A relationship of mutual benefit between two or more individuals or organisms.

**Wildlife:** Animals that exist and behave in their natural state; undomesticated.

**Hunting:** The sustainable activity of pursuing living sustenance or prey for survival or economic purposes.

**Culture:** The arts, Beliefs, customs, institutions, and other products of human work and thought considered as a unit, especially with regard to a particular time or social group.

**Health Act:** A piece of Legislation that relates to Public Health Laws.

**Life:** The property or quality that distinguishes living organisms from dead organisms and inanimate matter, manifested in functions such as metabolism, growth, reproduction, and response to stimuli or adaptation to the environment originating from within the organism.

**Just:** Honourable and fair in one's dealings and actions: synonym: fair.

**News:** Information specifically about actual events or happenings, especially as reported through newspapers, websites, radio, television, and other forms of media.

**Journalist:** One whose occupation is to write specifically about news in newspapers, magazines, radio, television, or Internet;

**Opinion:** A perception or inference on a situation, person or topic.

**Accuracy:** The condition or quality of being accurate; extreme precision or exactness; exact conformity to Truth, or a rule or model; correctness: as the value of testimony depends on its accuracy; copies of legal instruments should be taken with accuracy.

**Social Media Platform:** An online platform that seeks to replicate societies governance and information sharing qualities on the Internet.

**Data:** Individual facts, statistics, or items of information, often numeric. Data is a set of values of qualitative or quantitative variables about one or more persons or objects.

**Birth Certificate:** A paper validation of existence issued at birth.

**Mana Motuhake:** Self-determination with responsible sovereign autonomy.

**Evolution:** A gradual process in which something changes into a different and usually more complex or better form.

**Harmony:** A relationship in which various components exist together without destroying one another.

**Parasitism:** Living in a way that causes harm to one's host or surroundings.

**Climate Change:** The perceived impact humans have on the climate through certain unsustainable industrial processes.
